SPECIAL EVENT RULES

Flag Pole Race, Boat-Trailer Race, Roller Derby,
and Front Wheel Drive Demolition Derby



For all of the above events, the rules are simple. Any car, station wagon, mini-van, or two wheel drive pick up truck with a minimum wheelbase of 102 inches may compete. All you need to do is remove all the glass, head lights and tail lights, and chain or weld the doors closed. Windshield removal is optional. We do REQUIRE a working seat belt and a GOOD HELMET.

Boat-Trailer Race

To compete in the boat trailer race you MUST HAVE A REAL BOAT OR CAMPER TRAILER, 16 feet or larger. No pop-up campers, john boats or canoes. Boat motors and any other debris MUST BE REMOVED! Trailers may be pulled by any car, station wagon, mini-van or stock height two wheel drive pick-up truck (no 4x4's). All trailers must have safety chains.

Roller Derby

Roller Derby is a three car team event. Each team has two cars that run and one car that is not running. Your two running cars MUST BE painted your teams color. Your non-running car MUST BE painted white with your teams color stripe down the center of the hood, roof and trunk YOU MUST CALL TO RESERVE YOUR TEAM COLOR!!! The basics of the game are simple: use one of your running cars to push your non-running car around the track. Use your other running car

to stop the other teams from pushing their non-running car but you may not hit any other teams non-running car.



A one-time entry fee of \$35.00 is required, PLUS a pit pass, will allow you to compete in one or all of the night's events! Compact Enduro drivers are required to pay a separate entry fee. If you pre-register for the Compact Enduro, the entry fee for the special events is only \$25.

Approved helmets with shield or goggles, long sleeve shirt or jacket, and long pants are MANDATORY!! Gloves, fire suit and fire extinguishers are HIGHLY RECOMMENDED.

All drivers must be signed in at registration booth and all cars ready for tech no later than 4:30 pm day of the show. All drivers MUST BE present at drivers meeting. All drivers are responsible for themselves and their crew members. No drinking of alcoholic beverages prior to the demo...it will NOT be tolerated from anyone!!

All rules will be STRICTLY ENFORCED!!!! All decisions of event officials will be final. If you have any questions about any of the rules contact us FIRST before you do it. Officials have the final word in all areas.





Front Wheel Drive Demolition Derby Rules

A. MODEL

1. Any 1980 or newer four cylinder or V-6 front wheel drive car or station wagon with a wheel base of 102 inch or larger is eligible to compete. No straight six cylinder or V-8 cars, no four wheel or all-wheel drive cars will be allowed!

With the exception of the following safety modifications, all cars must be 100% STOCK!
Stock means the way that year, make & model came from the factory!

B. INTERIOR

1. All glass except windshield MUST BE removed. Windshield MAY BE removed but MUST BE replaced with wire screen or three steel rods to protect driver. All broken glass must be out of the car prior to coming to the track.
2. All carpet, door panels and head liners must be removed.

C. BODY

1. All body molding and lights must be removed.
2. Bumpers must be stock for that year, make & model. Bumper ends may be flat cut. Brackets may be welded to frame and bumpers but you may NOT add any extra metal. Trailer hitches MUST be completely removed.

D. HOOD

1. Hoods must be bolted or chained shut in no more than four points. Chains must not be larger than 3/8th diameter x 36 inches long. Bolts MUST NOT be larger than six inches long and 1/2 diameter. Bolts or chains MUST NOT pass through or around frame in any way!
2. Hood must have six inch hole cut in center to allow for fire extinguisher access.

E. DOORS

1. All doors and trunk lids must be welded, chained or bolted shut. Welds must not exceed 18 inches total per door or trunk.
2. Drivers door only may be welded solid or reinforced within reason.
3. Driver safety bars of not more than 3 inches diameter may be run form right to left at door post and windshield post.

I. TIRES

1. Must be stock 4 ply DOT radial car tires only! Tires must be stock size for the year, make and model. You may use tubes. No valve protectors!

J. BATTERY

1. May be relocated inside car but must be securely fastened and completely covered by a battery box or rubber inner tube or similar material.

K. FUEL TANK SYSTEM

PLEASE READ VERY CAREFULLY!

1. Cars that have a fuel tank located in the center of the car or forward of the rear axle may leave the tank in the stock location. All others **MUST** relocate the tank by using a boat tank or fuel cell and mounting it in the rear floor board.

L. SAFETY

1. Approved helmets with shield or goggles, long sleeve shirt or jacket, and long pants are **MANDATORY!** Gloves, fire suit and fire extinguishers are **HIGHLY RECOMMENDED.**

M. CONDUCT

1. We want this event to be fun, fair and safe for drivers and fans. All drivers are responsible for themselves and crew members. This is a **FAMILY** show, please govern yourself accordingly.
2. **NO** drinking of alcoholic beverages prior to the Demolition Derby will not be tolerated from anyone.

The foregoing shall constitute the limit of liability of the Speedway for such injuries occurring to me in any Speedway events; I unconditionally release and indemnify the Speedway regardless of the cause and nature of the injury or death.

COMPLIANCE: The undersigned agrees to abide by all rules and regulations of the Speedway and/or CarWarz, Inc. now or hereinafter promulgated. In consideration of the acceptance by the Speedway of this agreement, the undersigned recognizes his obligation to the public and the Speedway, which posts the prize money and conducts the event, and agrees to compete in all events when qualified if humanly possible.

BREACH & DAMAGE: In the event the undersigned breaches this agreement, he shall be liable for actual and liquidated damages sustained by the Speedway.

OWNERSHIP: As owner of a registered car, I certify I have marketable title to the competition vehicle, free and clear from liens and will deliver title to said vehicle or any part thereof if claimed pursuant to the rules.

ADVERTISING RELEASES: The undersigned consents to the use of his name, pictures of himself and his car for publicity, advertising and endorsements both before and after the events, and relinquishes any rights to photos taken in connection with events and consents to the publication or sale of such photos as the Speedway desires.

ARBITRATION: Any controversy or claim arising out of or relating to this agreement, including any alleged breach, shall be settled in accordance with the rules of the Speedway and/or CarWarz, Inc. The undersigned agrees to accept the decision as final without appeal.
